# EMERGENCY BLOOD SHORTAGE: SEVERE WEATHER FURTHER STRAINS RED CROSS BLOOD SUPPLY

The American Red Cross continues to experience a national blood emergency as remnants of Hurricane Debby and other severe weather events across the country have further complicated efforts to rebuild the nation's blood supply. Those in unaffected areas are urged to make an appointment to give now.

Weather in recent weeks has added to the summer shortfall in donations by forcing the cancellation of nearly 60 blood drives throughout the country, many of which were caused by Debby, causing approximately 1,500 lifesaving blood products to go uncollected. Annually, severe weather such as blizzards, tornadoes, floods and hurricanes impacts about 90,000 blood donations made to the Red Cross. In California, 108 blood drives have been canceled due to weather over the last 10 years, including 14 so far this year. This has resulted in about 386 donations going uncollected in Southern California in 2024. Because blood has a short shelf life and can only come from volunteer blood donors, any disruptions in the ability to collect lifesaving blood can have serious consequences for hospitals and patients.

First-time donors and those who give regularly are critical to blood supply recovery. To make an appointment, download the Red Cross Blood Donor App, visit RedCrossBlood.org or call 1-800-RED CROSS (1-800-733-2767). In thanks, all who come to give through Aug. 31 will get a \$20 Amazon.com Gift Card by email. See RedCrossBlood.org/Help for details.

Those who come to give Sept. 1-15 will receive an exclusive Red Cross raglan T-shirt, while supplies last. Be ready for emergencies

September is National Preparedness Month, and a strong blood supply is key to preparedness for disasters and medical emergencies. As disasters occur more often and become more powerful due to



the climate crisis, the Red Cross also encourages people to get their households ready for emergencies. This year the country has already seen the earliest Category 5 storm ever recorded with Hurricane Beryl, and wildfires have burned 2.7 million more acres compared to all of 2023.

Disasters can happen anywhere, at any time, often without warning. Get ready by making a plan to stay safe, gathering important supplies and knowing how you'll stay connected. # GIVE SUMMER GRILLING A SEAFOOD SPIN

Shake up your next family barbecue with fresh, flaky seafood. This Grilled Glazed Salmon may result in a new favorite when served over rice or alongside fresh veggies or a small salad. Find more summer grilling ideas at Culinary.net.

### Grilled Glazed Salmon

Recipe courtesy of "Cookin' Savvy"

Cook time: 15-20 minutes

Servings: 4-6

#### Dry Brine:

- 1/2 cup salt
- 1 cup sugar
- 1 cup brown sugar
- 2 tablespoons lemon thyme or lemon zest
- 3 tablespoons garlic powder
- 1 tablespoon pepper
- 1 salmon fillet (2-3 pounds)

#### Glaze:

- 1/4 cup brown sugar
- 1/4 cup ketchup
- 1/4 cup mustard
- 1/4 cup apple cider vinegar
- 1 tablespoon Worcestershire sauce
- 1 tablespoon garlic
- 2 tablespoons ginger salt, to taste
- pepper, to taste



To make dry brine: In bowl, mix salt, sugar, brown sugar, lemon thyme, garlic powder and pepper. Place salmon on cookie sheet and cover with brine. Refrigerate 10-12 hours, or overnight. After brining, rinse salmon completely.

Dry with paper towel and let rest at least 1 hour.

Heat grill to medium heat. To make glaze: In bowl, mix brown sugar, ketchup, mustard, apple cider vinegar, Worcestershire sauce, garlic

and ginger. Add salt and pepper, to taste. Brush over salmon.

Place cookie sheet with glazed salmon on grill and cook 15-20 minutes until internal temperature reaches 130 F. Let rest 5 minutes before serving.

His use of hand-dyed CDs for the body of the mermaid and an assortment of beach trash, empty Coke and water bottles, a potato chip bag, and fishing lines dragged behind the model in a train-like style highlighted the importance of environmental awareness in fashion.

Elizabeth McGhee won "Most Innovative Use of Materials" for her delightful trip down memory lane in a dress made entirely from recycled socks. Her playful nod to '80s and '90s prom dresses was nostalgic and inventive.

Nancy Swan was the show's double winner, receiving accolades for "Most Glamorous and Elegant Red Carpet Worthy Creation" and the coveted "People's Choice Award." Her Edith Head tribute, crafted from newspapers, trash bags, and bubble wrap, was a stunning homage to fashion's evolution from the 1800s to today.

Beyond the winners, other artists also wowed the crowd with their unique takes on sustainable fashion. From a breathable summer outfit made of fiberglass screen and luggage strapping to a traditional Japanese jūnihitoe reimagined with tissue and origami paper, the creativity on display was nothing short of extraordinary.

# EQUESTRIAN ESTATE ONCE OWNED BY WILL ROGERS HAS JUST SOLD FOR \$14.044 MILLION



Hollywood's highest-paid actor of the 1930s, Will Rogers got his start in vaudeville before venturing into film. He would go on to make 50 silent films, 21 "talkies" and over 4,000 syndicated newspaper columns. A citizen of the Cherokee Nation, the comedian was famous for his folksy style that allowed him to poke fun at gangsters, politicians, and the controversial issues of his day without offending the audience. His most well-known aphorism was, "I never met a man I didn't like." In 1926, he was made mayor of Beverly Hills, a largely ceremonial position that allowed him to further joke about "do-nothing politicians" and mounted a satirical campaign for president in 1928. Celebrated as a roper and rider, Rogers was also an aviation enthusiast who helped to popularize commercial air service. He died in 1935 when his two-man plane crashed in Alaska.

An equestrian estate built for the Golden Age star has just sold for \$14.044 million. Close to the beach that bears his name, the stunning compound boasts 3.3 acres and five separate structures: the main house, a staff house, a pool house, stables that housed Will's horses

and have now been converted into a gym, and a brand-new guest house. Michelle Pfeiffer, one of Hollywood's highest-paid actresses of the 1990s who, like Rogers, has a star on the Hollywood Walk of Fame, owned the estate in the 1980s. The most recent owners expanded the home and reimagined the look with the help of famed interior designer Michael S. Smith, who did the 2010 remodel of Barack Obama's Oval Office.

The historic main house sports a 6,250-square-foot floor plan with high ceilings and rustic wood beams. Bright white walls contrast with dark hardwood floors and accents. Walls of glass offer stunning garden views and lots of natural light. The rustic country kitchen opens to a romantic dining room and the enchanting two-level library, while the expansive primary suite includes a spa-inspired, en-suite bath and its own patio.

The main house is just the beginning: the staff house is a one-bed, one-bath brick unit with 446 square feet; the two-story guest house is a spacious 1,200-square-foot new construction; the pool house is over 1,000 square feet with a bathroom and spa; and the free-



standing gym is over 800 square feet. A rare gem with a large lot in Pacific Palisades, the park-like grounds still have space for horses. Meandering paths wind through enchanting gardens, offering a peaceful atmosphere just moments away from everything the city has to offer. A full-size pool and several covered patios make the compound an ideal summer sanctuary.

Pacific Palisades is a secluded, upscale neighborhood in LA's Westside, consisting of a strip of prime surf beach

and the rolling hills above it. A close-knit community with a small-town feel, it is rarely visited by tourists and has become a haven for celebrities. A few illustrious residents include Steven Spielberg, Tom Hanks and Rita Wilson, Whoopi Goldberg, and Matt Damon.

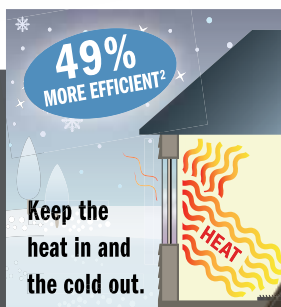
